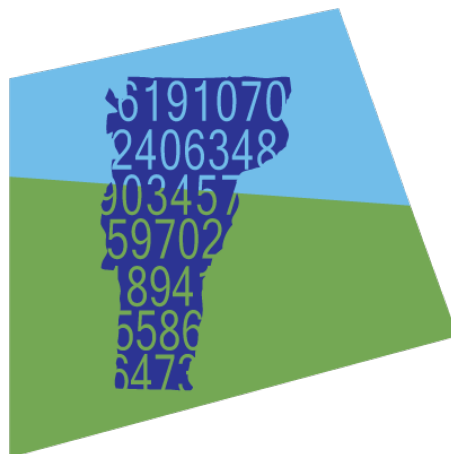

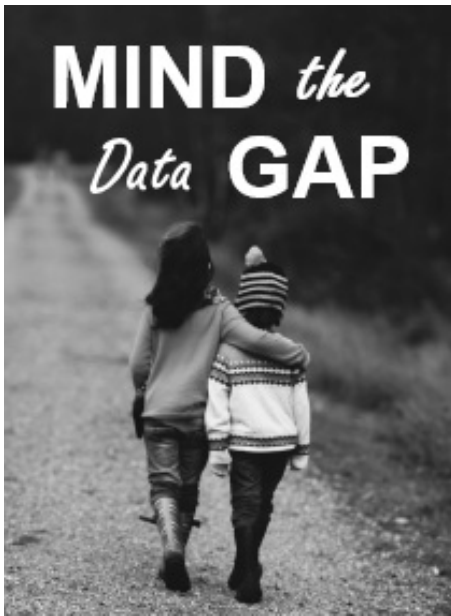
Future issues of this newsletter will discuss the implementation of the business plan, including successes and challenges.

Continued Partnership with the Vermont State Data Center, UVM

Mind the (Data) Gap: The Impact of Substance Use Disorder on Young Children and Families

Substance use (e.g., alcohol, tobacco and opiates) can have profound impacts on young children and families. To help Building Bright Futures understand and respond to this important issue, accurate and reliable data about substance use is needed at the state and local levels. Vermont Insights is putting together a "Mind the (Data) Gap" report, which:

- * defines key early childhood policy questions, asked by stakeholders, related to substance use;
- * reports on the strengths and limitations of available data that would help answer those questions, and;
- * offers recommendations to bridge data gaps and sustain data assets.

In **January 2017**, the report's findings will be presented to the newly formed Building Bright Futures State Advisory Committee (SAC) Task Force on Substance Use and the Opiate Epidemic: Impact on Vermont Children. Read the project summary below.

Immunizations (19 to 35 Months)

Summary: This report shows the count and percentage of children, ages 19 to 35 months, who received the full recommended immunization series (4:3:1:4:3:1:4) between 2013 and 2015. In 2015, 75.6% of Vermont's children in this age group received the full recommended immunization series. Grand Isle County (76.34%) and Chittenden County (70.25%) had the highest percentage among all counties.

Teenage Pregnancy

A recent [study](#) in the Journal of Adolescent Medicine suggests teenage pregnancy is down nationwide due to increased use of effective contraceptives. In 2012, Vermont was one of the ten states with the lowest birth rates (16.3 births per 1,000 females) for teens between 15 and 19 years old. The U.S. rate was 29.4 births per 1,000 females for the same age group and year.

Infants and Toddlers Likely to Need Care Without Access to (High-Quality) Regulated Child Care Programs

Developed by [Let's Grow Kids](#), this report will display estimated counts and percentages of infants and toddlers in Vermont who likely need care but do not have access to (high-quality) regulated care programs. Data filters will include geography, age groups, and STep Ahead Recognition System (STARS) ratings. Publication of the report is scheduled for **January 2017**.
